



LIMITED WARRANTY

Thatcher Retractable Products Inc. warrants the following to be free from manufacturing defects in material and workmanship during the warranty period:

FRAME COMPONENTS

Drop-Down Arm Retractable Awnings, Retractable Shades, Retractable Pergola Awnings and EZ Shades, Retractable SunStructures, & Fixed Frame Awnings and Patio Covers
Its frame components for a period of period of ten(10) years.

Thatcher Classic Lateral Arm Awnings
Its frame components for a period of seven (7) years.

Thatcher Premium Lateral Arm & Premium Plus Lateral Arm Awnings
Its *arm, shoulder, and connection components* for a period of twelve (12) years.
Its *roller tube, front bar, and square bar* for a period of twenty (20) years;

FINISH

The paint finish shall be warranted for a period of five (5) years.

FABRIC

This limited warranty protects the original purchaser from the fabric becoming unserviceable due to color or strength loss from normal usage and exposure conditions, including sunlight, mildew, and atmospheric chemicals. The limited warranty coverage material is ten (10) years from the date of the original installation and covers full replacement of the fabric.

SCREEN FABRIC, WINTER COVER FABRIC, WIND POLES, AND OTHER ACCESSORIES

Material is warranted for a period of five (5) years.

ELECTRIC/ ELECTRONIC COMPONENT PARTS

Its *electric/electronic component parts*, including and specifically limited to switches, plugs, receptacles, motors, controls, and all necessary components thereto, for a period of ten (10) years. Warranty is void if motor is connected to any other power source than an exterior GFCI Outlet with a protected cover.

All time periods delineated herein shall begin to run from the date of delivery.

Should any of the aforementioned frame, fabric or electric/electronic component parts prove to be defective within the warranty period, upon receipt of written notice from the purchaser within the warranty period, Thatcher Retractable Products Inc. shall, at its own option, repair and/or replace such product(s), or part(s) thereof, which prove to be defective, at no cost to the purchaser. Any liability of Thatcher Retractable Products Inc. under this Limited Warranty is specifically and solely limited to the cost of the repair and/or replacement of the defective component part(s).

This Limited Warranty does not apply to any damage, inoperability, or inefficiency, due to or the result of misuse, neglect, faulty maintenance or accident by the purchaser, its employees, or any third party. This Limited Warranty does not apply to normal wear and tear, or to any loss due to an Act of God, including but specifically not limited to fire, wind, windstorm, rain, sleet, hail, snow or ice.

In the event that Thatcher Retractable Products Inc. provided installation for retractable awning products, field service labor will be covered for a period of one (1) full year from the date of installation.

In the event that Thatcher Retractable Products Inc. provided installation for retractable awning products, Thatcher Retractable Products Inc. warrants the installation of the awning brackets for a period of three (3) years from the date of installation.

Thatcher Retractable Products Inc. warrants that all products installed by Thatcher Retractable Products Inc. to be installed according to generally accepted industry standards.

This Limited Warranty does not apply in any case where the structure the awning is attached degenerates for any reason including but not limited to wood rot, fire, construction, or wind damage.

Thatcher Retractable Products Inc. is not responsible for any actions taken by the purchaser that results in damage to the structure. This includes, but is specifically not limited to the removal of the awning, electric cord, or any other item contracted and installed by Thatcher Retractable Products Inc.

Thatcher Retractable Products Inc. is not responsible for damage to the structure that occurs in the normal installation of any product including, but not limited to, the removal of the product from the original place of installation.

Thatcher Retractable Products Inc. is not responsible for any outside labor, and cannot be compelled to pay for field service provided by any other company other than Thatcher Retractable Products Inc.

Thatcher Retractable Products reserves the right to refuse field service after the warranty period expires.
